### **80TH YEAR** ANNIVERSARY OF NANI PALKHIVALA AS A LAWYER (1944-2024)

The Legal Convention 2024 is proud to commemorate the 80th anniversary of Nani Palkhivala's illustrious career as a lawyer, celebrating his unparalleled contributions to the Indian legal system and his enduring influence on constitutional law.

#### The Life and Legacy of Nani Palkhivala

Nani Ardeshir Palkhivala was born on January 16, 1920, in Bombay (now Mumbai). From humble beginnings, Palkhivala rose to become one of India's most distinguished jurists, known for his exceptional intellect, eloquence, and profound understanding of the law. He began his legal career in 1944, and over the decades, he established himself as a towering figure in Indian law, admired for both his legal acumen and his unwavering commitment to justice. Palkhivala's expertise spanned various branches of law, including constitutional law, taxation, and civil liberties. He was a formidable advocate, known for his clarity of thought and his ability to present complex legal arguments in a manner that was both persuasive and accessible. 




## **Theme** of Convention

Chandigarh city in India came into existence in 1952 when its foundation stone was laid. Also known as *The City Beautiful*, Chandigarh is one of the modern cities of India designed by the French architect Le Carbusier. Serves as the capital city of two states i.e. Punjab and Haryana.



In the ancient past, a wide lake existed where now Chandigarh is with its sloping plains. Eight thousand years ago, around 1900 to 2500 BCE, the Harappan civilization developed in the area.

The city of Chandigarh has been an international topic of interest since its inception because of its immense historic as well as architectural and planning values. This unique experiment was further celebrated in 2016, when the Capitol Complex designed by Le Corbusier was inscribed in UNESCO's World Heritage List as a part of the transnational serial inscription namely 'The Architectural Work of Le Corbusier, an Outstanding Contribution to the Modern Movement'.

With a state of the art international airport and a modern railway interconnectivity station, the city boasts in its pride of being a well planned modern getaway from metropolitan hustle. Perched at the foothills of the Shivalik range, Chandigarh is widely renowned for its lush greenery, cleanliness, scenic beauty, and unparalleled air & quality of life. 






# VISION **STATEMENT**
